Advisory in respect of COVID-19 for Empanelled Hospitals and Common Service Centres/Lok Mitra Kendras.

This is in continutation to the advisories issued by State Government from time to time regarding COVID-19. As you are aware that beneficiaries under Ayushman Bharat-PMJAY/HIMCARE are visiting CSCs/LMKs/Empanelled Hospitals for preparation of cards and availing the cashless treatment. Following instructions are issued to prevent/avoid the disease transmission in the community with immediate effect in the public interest:-

- 1. All the LMKs/CSCs/Empanelled Hospitals should not allow mass gathering for card preparation. One person from family can deposit the documents for enrollment/renewal under HIMCARE. Only one person from family may be asked to visit the LMK/CSC/Empanelled hospitals for card print after receiving the approval message on mobile through portal. While enrolling under Ayushman Bharat, where biometric authentication is required, only one person should be allowed to enter the CSC/LMK/Empanelled Hospital counter for enrollment at a time and devices must be cleaned with freshly prepared 1% Sodium Hypochloride Solution after every use.
- 2. Since the patients are visiting for availing cashless treatment in the Empanelled Hospitals and as per guidelines of Ayushman Bharat-PMJAY, bio-auth is mandatory for admission, hence it is advised that biometric device must be cleaned with freshly prepared 1% Sodium Hypochloride Solution after every single use.

Kendras are directed to follow the above instructions till further orders.
