Subject:- Advisory on Novel Corona Virus 2019 (Covid-19) for
inmates of Old Age Homes, Day Care Centres and
Educational Institutions for specially abled children


Sir

Keeping in view the increasing impact of Corona Virus in the State of Himachal Pradesh, I am directed to say that since the older persons and children are more prone/ susceptible to the infections/ viruses, a special care/ precautions are required to be taken to the inmates of Old Age Homes, Day Care Centres and Educational Institutions for specially abled children of the State of Himachal Pradesh. Further to reduce the risk of spread/ transmitting the virus among these inmates, if the parents/guardians of these children want to take them back to their home for care, they may be allowed forthwith following due procedures. Similarly, if the older persons of these homes/ day care centers also want to go back to their home, they may also be allowed accordingly.

The instructions may be adhered forthwith and all concerned Govt. institutions/ NGOs running such Old Age Homes, Day Care Centres and Educational Institutions in the State may be issued directions immediately.
