Subject: Report on supportive supervision of Sirmour Distt.

Sir,

It is informed that I have conducted the supportive supervision of some Health Institutions in Sirmour District on 9.3.2015 and 10.3.2015. The detailed report of inspection of these institutions is as under:-

9.3.2015 **Public Health Centre Nainta Tikkar.**

- This Health Institution is functioning in local Panchayat shops.
- No part time helper/sweeper is employed. The condition of sanitation and cleanliness is very poor.
Construction of New Building is urgently required. Funds for this purpose are already available with PWD for the last more than 3 years. Apart from it Class-IV needs to be posted immediately.

Health Sub-Centre Bag-pasog.

At 11 Am this Health Sub-Centre was found locked.

Civil Hospital-Sarahan

- 2 generators have been installed in this Institution but both are not functional.
- Labour Room- No Elbow tap and no room thermometer was found in the labour room.
- There exist one Bed in the Labour Room which needs to be removed/shifted immediately.

- There is urgent need of fully automatic blood analyzer in the lab.
- There is shortage of sweepers.
- BSY is required.

Health Sub-Centre Barah-Ki-Ser

- At 3.30 PM this centre was found locked.

10.3.2015

District Hospital Nahan.

- Labour room is very congested which needs intensive renovation on priority basis in the interest of mother and child health care.
 - In the Labour Room there are no protocols, no wall thermometer, no elbow tap and parto graphs not maintained.
 - CMO Nahan has been suggested to submit detailed estimate immediately for arranging funds.
 - Application stands moved to renew the blood bank license which needs to be pursued to get the renewal immediately.
 - MCH- No due list found prepared/maintained.
- Thereafter meeting was conducted with the Programme Officer and BMOs. All Programme of NHM were discussed in detail and observations/shortcomings were explained in detail to them.

Recommendations:

1. PHC- Naina Tikkar = Class-IV is required to be Provided on priority.
2. Civil Hospital-Sarahan= Sweeping work needs to be Outsourced+ Fully automatic Blood analyzer.
3. RH-Nahan = Renovation of Labour Room

It is requested that necessary direction may kindly be issued to the CMO Sirmour to remove these deficiencies noticed during the course said inspection.

Subject: Report on supportive supervision of Solan Distt.

Sir,

It is informed that I have conducted the supportive supervision of some Health Institutions in Solan District on 15.1.2015 and 16.1.2015. The detailed report of Inspection of these Institutions is as under:-

16.1.2015 Health Sub-Centre Bathalag, Tehsil Arki.

Both worker were present and cleanliness of the Institution was proper. However immunization chart was not found displayed . -Delivery kit were lying unopened and unused in this Institution.

36 years Female reported a case of abortive after 2 female issues needs to be investigated.

BMO Office Arki.

Meeting of all Health Workers, Supervisors, Health Educator of the Arki Block was conducted and all activities/programmes of NHM discussed in detail.

Labour room at Arki Hospital is very congested. Essential new born care and active management of 3rd stage of Labour protocols was not found displayed.

Staff deployed at delivery points needs to be trained in PPIUCD.

Blood storage unit needs licensing despite having the availability of required infrastructure for this purpose. Process to obtain the license needs to be started immediately.

Meeting of health workers is being convened quarterly. It should be on monthly basis.

Health Sub-Centre Gambhar

Both worker were present and cleanliness of the Institution was proper. However immunization chart was not found displayed . Delivery kit were lying unopened and unused in this Institution. ANC after one month was taken as 2nd ANC. It should be on trimester mission basis

Civil Hospital Kunihar

Labour Room approach/passage being used as Minor OT. Inside the Labour room furniture was found stored. -Minor OT needs to be shifted so some other place whereas furniture articles stored inside the Labour room should be shifted at once so that the Labour room remain decongested. The Medical Officer supplied the list of medicine which are required in this health Institution for patient care services which may be arranged immediately.

16.1.2015 PHC Deothi.

Although this PHC has started furncionioning in new Building but required furniture needs to be provided. This building require immediate furnishing. Despite sufficient availability of staff MCH services has not been srated as yet which needs to be started now immediately in this Institution. The IEC material be displayed.

CMO Office Solan.

Meeting was conducted with the Programme Officer and BMOs. Three BMO and one representative of another BMO were present in the meeting. All Programme of NHM were discussed. Unreported delivery to be taken care of was stressed. Supportive supervision check list was circulated to all BMOs with direction to conduct monthly supportive visit of the Institutions in the Block

Distt. Hospital Solan.

Labour room . 2 patients were found in the labour room. No standard operating procedure has been displayed in the Labour Room. Elbow tap instead of normal tap be provided

No partograph was maintained. No staff trained in SBA/JSSK.
MCH Centre. Old guidelines being displayed which needs to be replaced with new guidelines of JSY.

It has also been observed that immunization in MCH centres at Block level is being done on daily basis whereas this should on the day fixed for this purpose so that the services of staff could be utilized for field visits.

It is requested that necessary direction may kindly be issued to the CMO Solan to remove these deficiencies noticed during the course said inspection.
