Report: Supportive supervision in District Mandi

Reference office order No. HFW -H(NRHM) Gen Estt./2013, Dated 17th December 2015, supportive supervision in District Mandi was conducted in January, 2015.

Health Institutions visited

1. CHC Padhar-FRU
2. PHC Barot-Delivery point
3. Health Sub centers
 - a. Jhatangiri
 - b. Barot

Details of Physical infrastructure, Human resource, Training status of HR, equipment, essential drugs/ supplies, lab services, service delivery in last 2 quarters, quality parameters, record maintenance, referral linkages, IEC display, support/additional services and previous supervisory visits are attached for each institution on prescribed formats.

Meeting at the District headquarters with the District Officer of Health, District Programme Officers and Block Medical Officers was held on 23rd January, 2015. The progress under Maternal Health, Community processes and Adolescent health was reviewed and measures to improve performance wherever required were discussed in detail. Issues regarding HMIS were discussed. The achievement under various trainings and outreach camps was reviewed and schedule for remaining activities during this financial year discussed.

Salient observations and recommendations:

- Record keeping satisfactory but universal registers for various programmes are required to ensure uniformity and avoid duplicity
- There is practically no supportive supervision from PHCs, Blocks, and District to Peripheral health institutions. Supportive supervisory visits need to be made mandatory at all levels
- Entitlements under various schemes like JSSK, JSY etc. are not displayed at health institutions. Entitlements under various schemes need to be prominently displayed at each health institutions.
- 'Yuva Paramarsh Kendras' centres non-functional
- New generators installed by HLL at Karsog, Jogindernagar and Sandhol are not functioning. The matter needs to be taken up with HLL.
