In continuation to this office order dated 14-03-2020 and owing to Covid-19 threat, as a preventive measure, all Anganwadi Centres of Himachal Pradesh shall remain closed for children till 31<sup>st</sup> March, 2020. However, Anganwadi staff i.e. Anganwadi Workers/Helpers and Mini Anganwadi Workers will be present in the Anganwadi Centres and shall maintain record as per ICDS-CAS parameters and shall perform other duties assigned to them in AWCs.

Furthermore, Take Home Ration (THR) shall be distributed for the period of 15 days i.e. upto 31<sup>st</sup> March, 2020, to all beneficiaries i.e. children in the age group of 3-6 years, pregnant women, lactating mothers. Necessary entries be ensured in the Dainik Poshahar Module of ICDS-CAS - AWW App.

Proper cleanliness and sanitation is to be maintained in all Anganwadi centres mandatorily.

Instructions in view of COVID-19.

Madam,

In continuation to this office order No. 14-9/2011-ICDS dated 14/03/2020 and in compliance of the instructions issued by the Additional Chief Secretary(Health) to the Government of Himachal Pradesh vide letter No. HFW-A-A(3)1/2020 dated 14/03/2020, you are directed to take following steps as preventive measure for the benefit of inmates of Nari Sewa Sadan Mashobra:-

1. Entry of outsiders in Nari Sewa Sadan be completely restricted.
2. Adequate quantity of disinfectants and cleaning agents like soap, sanitiser, phenyl etc. be made available 24x7 in Nari Sewa Sadan and the inmates be encouraged for regular hand washing with soap.
3. Washrooms/ toilets be cleaned regularly with cleaning agents/ disinfectants.
4. Teaching/ coaching and other group activities in Nari Sewa Sadan be also suspended till 31/03/2020.
5. All instructions issued by the Health Department/ District Administration etc. from time to time in this regard must also be followed strictly.
